MEMBERSHIP PAYMENT FORM 2023-2024

Payment of Dixie Curling Club fees will be made through the Dixie website. Either one or two payments are acceptable, with the two-payment option including a \$20 administration fee. All fees include membership fee, Curling Canada fee of \$2, and all applicable taxes.

Registrations are considered complete once full payment (one or first of two accompanied with appropriate second payment) has been received. Failure to either complete your registration online or submit your payment may impact your ability to curl in some of the more popular leagues.

Members can submit their registration starting July 17, 2023. The preferencing date for Returning Members is August 1, 2023. For those leagues where preferencing rules apply, all Returning Memberships received prior to the preferencing date will be considered received as of August 1, 2023. All initial payments will be processed upon receipt after registration opens July 17, 2023. For the two-payment option, the second payment is due November 1, 2023 and includes a **\$20 administration fee**. Please use this date for post-dated cheques made payable to Dixie Curling Club Ltd.
